Privacy Policy

This Privacy Policy ("Policy") applies to Vtcord.com, and Virtual Transaction Coordinators ("Company") and governs data collection and usage. Collection of your Personal Information

Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties.

All such third parties are prohibited from using your persona information except to provide these services to the Company, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Security of Your Personal Information

- SSL Protocol

Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of anther consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with certain state's Electronic Communications Privacy Act;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which the consumer provided the information.

Children Under Thirteen

The Company does not knowingly collect personal identifiable information from children under the age of 13. If you are under the age of 13, you must ask your parent or guardian for permission to use this website.

Email Communications
